Note: While signing this certification is not required to umpire, failing to do so may prevent being assigned to leagues or jurisdictions requiring assignors to assign officials that meet these criteria. This specific requirement is becoming more commonplace as contracts are renewed and agreed upon.

A background check fee of \$5.00 is mandatory for all umpires, including NEW and Life Members.

Instructions:

- 1. **All umpires** complete the name/address information and certification regardless of the year(s) of experience.
- 2. Whether you umpire college, high school, recreation, or all, **all members** pay the same amount for the annual dues to the association. Dues support our initiatives for training, ratings, evaluations, and various administrative expenses to operate the association, and are tax-deductible.
- 3. **Maryland HS umpires**–pay your annual MD fee directly by you for MPSSAA through NFHS/DragonFly. You will declare a primary association affiliation.
- 4. **Virginia HS umpires**–pay your annual Virginia fee directly to VHSL through **vhsl.org**.
- 5. **If you pay by** March 1st, a deduction of \$15.00 is applied as a thank you for your prompt payment.
- 6. **Umpires and candidates taking classroom instruction** for the first time, pay training fees (if any) to your trainer.
- 7. **LIFE MEMBERS**–You pay only the background check fee, and state High School fees per above instructions. Life members enter "LM" in Step 1 below. *Note: LM do not get the prompt discount payment.*
- 8. **Rule Books**–if **MAC/NVBUA** is your primary Maryland association and all VHSL umpires will get a rule book from us. **Maryland umpires** will receive rule books through your primary umpire association identified at MD registration. You can also purchase searchable e-book version at **NFHS.org**.
